Note: We enroll co-parents (exes) into **separate** groups to promote full participation and self-reflection. *Current* partners may attend together. (Please advise Tami if your "ex" might need to call/enroll also.)

*An "assessment" with the group facilitator is required before attendance can begin. (*Groups for Anger Management are created based on # of attendees & may be 1:1 if group size decreases.*) An **"Anger Mgt. or D.V. Assessment" with an outcome letter (for attorney/court/school) is \$100 total.**

****Fee Information:** If you are paying out-of-pocket, the fee for each group is based on your gross, monthly, household income using a sliding scale. (Current couples attending together pay the regular/max. fee instead of a per person fee.) All fees include a proof of enrollment letter, handouts (or workbook for Co-Parenting), and a certificate of completion. Some fees also include the pre-group assessment. *If a 3rd party/agency is paying for your attendance, a pre-authorization for payment is required. You are personally responsible for paying for any absences &/or make-ups - depending on the class/program. (Ask your worker to call Tami at 530-626-5164 x23.)*
